

2) Certain beneficiaries were ordered to reimburse the estate for a distribution overpayment, but have refused to follow this Court's Order (Judgment Entry attached and marked as Exhibit Two). The Fiduciary is in the process of filing a contempt action against these individuals. 

JUDGMENT ENTRY

This matter came before the Court upon a Motion to Reimburse Overpayment to Fiduciary filed by the Executor. Present at the hearing were Attorney Stephen A. Ginella on behalf of the estate, Laura Warner, Connie Hollandsworth, Linda Navakowski, Daniel Baich. Beneficiary James Baich did not appear. The amount requested to be returned from each beneficiary is \$2,577.78.

Attorney Ginella provided documentation that notice of the overpayment and a request to stop payment on the checks had been provided to the Executor within a week of its determination. However, the Executor did nothing. All of the beneficiaries present at the hearing testified that they had spent all the money distributed and could not afford to pay back the full amount individually owed of \$2,577.78. Each stated that they could pay \$100.00 per month back to the estate. It is hereby

ORDERED that the beneficiaries Laura Warner, Connie Hollandsworth, Linda Navakowski, Daniel Baich and James Baich each pay \$100.00 each month the Estate of James Baich until the overpayment of \$2,577.78 for each beneficiary is paid. The first payment is due on September 1, 2014 and on the first day of the month thereafter. Failure to comply with this Order may result in a finding of contempt and appropriate sanctions.
