I, ROSEMARY E. SABO, wife of JOSEPH F. SABO, as Testatrix, of the Village of Canal Fulton, County of Stark, State of Ohio, declare this to be my Last Will and revoke all former Wills and Codicils.

ARTICLE I

Identification of Family

— My immediate family now consists of my husband, JOSEPH F. SABO, children: —

CHARLES F. SABO ELIZABETH A. FORD SUSAN M. SIDELINKER

MICHAEL J. SABO

Except as provided below, I make no provisions in this will for any of my children who survive me, whether named herein or hereafter born or adopted, nor for the descendants of any child who does not survive me.

ARTICLE II

Residual Bequest

I give the residue of my estate to JOSEPH F. SABO, or his successor, as Trustee under the Trust Agreement in which we are both Trustee and Trustor, dated April 28, 1998 and said property shall be added to the Trust fund and be held and distributed as a part of the fund.

ARTICLE III

Appointment of Executor

I appoint JOSEPH F. SABO and ELIZABETH A. FORD as the Executor of my estate, provided that when two or more persons are named to act, they shall, unless designated to act as Co-Executors, serve individually, with preference in the order named. Should any one or more of those named fail to qualify or cease to act, then the next one in order to so qualify shall act as my Executor. My Executor, to serve without bond, shall have the power, without court order, but subject to court review, to mortgage, encumber, lease, sell, exchange and convey any asset of my estate, real or personal, to advance funds and borrow money, secured or unsecured, from any source. Further, the Executor may make distributions in cash or in kind, or both, in shares which may be composed differently, and do so without regard to the income tax basis of specific property allocated to any beneficiary (including any trust). My Executor may invest and reinvest the property of the estate and may acquire and sell any form of real or personal property. Without limiting the generality of the foregoing, my Executor is authorized to buy and sell such property through brokers of my Executor's choice (subject to using due care in the

selection of such brokers) and to pay the usual and customary charges. I authorize my Executor to appoint an ancillary personal representative or agent if such should become necessary or advisable in the judgment of my Executor. Such powers may be exercised whether or not necessary for the administration of my estate.

ARTICLE IV Taxes

My Executor is directed to cooperate with the Trustee under the Trust Agreement identified in Article II above in the payment of all estate, inheritance and succession taxes assessed by reason of my death. I waive for my estate all rights of reimbursement from the beneficiaries for any such payments.

ARTICLE V Definitions

- A. All references to children and descendants shall include adopted children.
- B. Unless some other meaning or intent is apparent from the context, the plurals shall include the singular and vice versa, and masculine, feminine and neuter words shall be used interchangeably.
