This case came to be heard upon the Motion of the Guardian of the Person, Faith Lanshe ("Guardian") for Mary James and Theresa Flohr to Show Cause Why They Should Not Be Held in Contempt of the Court's Orders. The Court heard testimony regarding allegations of violations of the visitation schedule imposed by the Court in its April 23, 2014 Judgment Entry that was reiterated in the Court's April 13, 2015 Judgment Entry. The Court modified the visitation schedule to include a morning visitation from 9:00 a.m. until 12:00 p.m. and an evening visitation from 4:00 p.m. until 8:00 p.m. The Court further ordered that the monthly visitation be submitted to the Court and be made part of a court order.

It is therefore ORDERED, ADJUDGED and DECREED that for the month of May, 2017, the following visitation schedule shall be imposed:
